

Articles of Association  
Nagoya Fulbright Association (Translation)

Chapter 1: General Rule

Article 1 The name of this association shall be called Nagoya Fulbright Association

Article 2 The Office of the Association shall be located in Nagoya.

Article 3 The object of the Association shall be to promote friendship among the members, and to further enlighten the members through the sharing of experiences and networking of information, thereby developing friendly relations and deepening mutual understanding between Japan and the United States.

Article 4 Membership of the Association is divided into five categories: Regular Members; Associate Members; Supporting Members; Honorary Members and Senior Members.

- Article 5
1. Regular Members: Grantees of GARIOA/Fulbright Scholarship
  2. Associate Members: American grantees staying in Japan under the Fulbright Program
  3. Supporting Members: Those who assent to the object of the Association, subject to approval by the Board of Directors
  4. Honorary Members: Regular Members who contributed to Association greatly, subject to approval by the Board of Directors.
  5. Senior Members: Regular Members who offer for oneself, subject to approval by the Board of Directors.

Chapter 2: Activities

Article 6 The Association shall carry out the following activities

1. Conduct activities intended to activate the exchange and deepen friendly relations among the members.
2. Provide guidance and assistance to grantees who will visit the United States under the Fulbright or other scholarship program.
3. Provide guidance and assistance to Fulbright grantees staying in Japan for their research activities and offer advice and support in everyday life.
4. Conduct activities designed to deepen mutual understanding between Japan and the United States, as well as those deemed necessary by the Board of Directors.

### Chapter 3: General Meeting

Article 7 There shall be an annual General Meeting. The Board of Directors may call an Extraordinary General Meeting whenever the Board deems it necessary to do so.

Article 8 The General Meeting shall:

1. Hear the report of activities, and approve the budget of income and expenditure and the settlement of accounts.
2. Elect the Directors and the Auditors.
3. Decide on any other important matters pertaining to the Association's management.

Article 9 Resolution shall be made by the majority of members present.

### Chapter 4: Directors

Article 10 The Association shall have a Chairperson, a few Vice Chairs, a few Committee Members, and Auditors.

Article 11 The term of office of a Director, a Committee Member or an Auditor shall be two years. They shall be eligible for re-election.

### Chapter 5: Accounts

Article 12 Expenditures incurred by the Association for its management shall be financed by membership dues, donation, and other miscellaneous income.

Article 13 Annual membership dues shall be ¥3,000 for Regular Members and ¥10,000 for Supporting Members, while Associate Members, Honorary Members and Senior Members with offer for oneself shall be exempted from the dues.

Article 14 The Association's fiscal year shall start on April 1 and end on March 31 of the following year.
